

B. PHARM.

The College offers a four years (Eight semesters) B. Pharm programme affiliated to the University of Mumbai.

INTAKE: 100

For B. Pharm course, out of the total 100 seats, 51 are for Minority quota, 20 seats are for Institutional quota and remaining 29 seats are for open category. Minority quota & Open category seats to be filled through centralized admission process by DTE and 20 seats of management quota to be filled at Institutional level.

ADMISSION CRITERIA FOR B.PHARM.

Admission to the B. Pharm program is governed by the rules and regulations of Directorate of technical education and Mumbai University as per norms of the Pharmacy Council of India (New Delhi).

Minimum qualification for admission to Bachelor of Pharmacy program is in accordance to the rules and regulations of PCI, AICTE, DTE and Mumbai University.

At the end of Sem. IV the learner will submit a thesis to the university. This will jointly be evaluated by the guiding teacher and an external examiner appointed by the university from academia or from the pharmaceutical industry. The evaluation will be for a total of 100 marks. Co-curricular Activities

(Attending Conference, Scientific Presentations and Other Scholarly Activities) and research publication have minimum 2 and maximum 7 credits to MPharm students.

GENERAL RULES & REGULATIONS

- 1. On the first day of college, the student has to attend orientation program with his/her parent so as to get detailed information about college and the course.
- 2. The student is required to reach the college half an hour before scheduled time. He/she cannot leave the college before time as given in the scheduled time table.
- 3. Identity card is compulsory; otherwise student will not get entry into the college.
- 4. If any student damages any property of college, he/she will be penalized by Disciplinary Committee.
- 5. It is expected that proper dress will be worn by the student. It is to be noted that for girls, any dress above knee length and singlet is not allowed.
- 6. Importantly, the ward and parent have to sign the Undertaking framed by the college comprising of Rules and Regulations of the University and College.
- 7. The student is not allowed to use mobile inside the College Premises. If he/she is found using mobile then College Authorities will take appropriate disciplinary measures.
- 8. If a student remains absent in either periodic (Theory or Practical) test then he/she will be marked absent and no any retest will be conducted. The student has to write the class test and complete assignments in due course of time. Journals are required to be completed and get checked on the same day of practical.
- 9. Condition of minimum attendance: The Students will not be allowed to appear for the examination if he/she do not attend minimum 75 per cent classes of theory and practical.
- 10. The student is required not to be indulged in any behavior or act that may come under definition of ragging. He/She will not participate or propagate in any form. He/she will not hurt anyone physically or psychologically or any other harm. If found guilty of any aspect of ragging, he/she may be punished as per the provision of UGC Regulations or as per law in force.

RAILWAY CONCESSION

Students aged below 25 years can avail this concession. The railway concession is issued for local travel i.e. station closest to residence to Jogeshwari/ Ram Mandir station. Applications for railway concession has to be made in the prescribed format available in the college office. For long journey to the home town and return, the forms will be issued only for the vacation period. The students should write their home town address in the application form for availing this concession


